The District will now begin accepting applications for round 1 until April 28, 2023 for the Agricultural Conservation Assistance Program (ACAP) for funding to implement agricultural conservation practices. These applications will be ranked on May 17, 2023.

Remaining Application & Ranking Schedule for 2023:

◆ Round 2 July 24, 2023 deadline August 9, 2023 ranked

• Round 3 November 15, 2023 deadline December 13, 2023 ranked

To be eligible, an applicant must have a conservation plan or agricultural erosion and sediment control plan and a manure or nutrient management plan.

The following are examples of the BMPs that may be implemented through the ACAP program:

- Agricultural stream accesses
- Heavy Use Areas with or without a roof
- Roofed Manure Stacking Pad
- Exclusionary & Streambank fencing
- Spring development
- Streambank Stabilization Structures

Pre-application site visits are required for the District to assist the potential program participants to ensure the application they submit is in the best interest of the applicant and the program. 
No-Till Drill Available For Rent


The District recently purchased a Great Plains 10' No-Till Drill now available for rent by landowners within McKean County. The following rates have been established:

- \$12.00 per acre or \$24.00 per acre if used on conventional tilled ground.
- Free use of the drill up to 30 acres if planting a non-harvested cover crop.

The District will transport the drill; however, landowners leasing the drill will pay a \$25.00 delivery fee within McKean County.

Do you need a Permit?



With spring fast approaching landowners begin to think of all the projects they want to get completed this year. The McKean County Conservation District reminds landowners and contractors that certain activities may require permits or erosion and sedimentation plans.

Before beginning your project, it is important to check with your municipality and county planning office regarding their requirements and building permit information. Also, check with the District about requirements for erosion and sedimentation and work near waterways.

Here are a few guidelines when planning your project.

If your project:

- ◆ Will have less than 5,000 square feet of earth disturbance, it is not necessary to have a written plan on site but **erosion** and sediment control best management practices (BMPs) are required to minimize the potential for accelerated erosion and sedimentation.
- Will have more than 5,000 square feet of earth disturbance, a written E&S plan is required to be on site and implemented.
- Will have more than 1 acre of earth disturbance and is not in a special protection (Exceptional Value, High Quality) watershed, a General NPDES Permit is required to be submitted for approval to the District. Before any earth disturbance activity can occur the plan must be approved. A copy of the approved stamped, signed, and dated plan must be kept on site.
- Will have more than 1 acre of earth disturbance and is in a special protection watershed, an Individual NPDES Permit is required to be submitted for approval to the District. Before any earth disturbance activity can occur the plan must be approved. A copy of the approved stamped, signed, and dated plan must be kept on site.
- Is timber harvesting or road maintenance activity involving 25 acres (10 hectares) or more of earth disturbance, an **E&S** Permit is required to be submitted for approval to the District. Before any earth disturbance activity can occur the plan must be approved. A copy of the approved stamped, signed, and dated plan must be kept on site. Timber harvests with less than 25 acres of earth disturbance are required to have a written **E&S** plan posted on site and implemented.

Project Spotlight

Streambank Stabilization/Fish Habitat Project

The project, pictured here was along Potato Creek in Norwich Township. The soils along the streambank here are very sandy which lead to a high amount of erosion. This was leading to high sedimentation loads into the stream, and large amounts of property belong lost as well.

The project was designed here to minimize both the sedimentation loading and the streambank erosion as well as maximize the fish habitat. A 100' modified mud sill was installed to eliminate the erosion and maximize fish habitat. The total project cost was \$6,590.00

This project was designed in a manner to work with the stream and what it is trying to do, if possible instead of working "against the flow." It was also

important to increase the value of the habitat and utilize more natural techniques. The foundation of these projects were to utilize logs that average 6 to 12" in diameter of either larch or hemlock species. Rebar rods are used to pin the logs together and to secure the logs to the stream bottom.

The type of structure will vary depending on what the stream is trying to do. Mud sills provide excellent overhead cover best suited for lower gradient streams with steep, eroded banks. They provide stream bank stability and create a stable undercut bank effect for fish cover.

Comments Open for Proposed PCSM Manual



The Pennsylvania Department of Environmental Protection ("DEP") has proposed a number of significant changes to its Post-Construction Stormwater Management ("PCSM") Manual. PCSM requirements potentially impact construction projects across the Commonwealth, especially those involving land disturbances of greater than one acre. The substantial revisions that are proposed by DEP in the draft Pennsylvania PCSM Manual are summarized as follows:

• New interpretive guidance on the PCSM regulations (25 Pa. Code § 102.8 (relating to PCSM requirements).

- A proposed hierarchy of stormwater management objectives.
- Additional detailed information on the performance of the stormwater analysis that is required for PCSM at 25 Pa. Code § 102.8(g), including the addition of new methodologies for the analysis of volume, water quality and rate management.
- Proposed criteria for the protection of wetlands.
- New best management practices—which are referred to in the draft Pennsylvania PCSM Manual as stormwater control measures (SCM)—including, but not limited to, managed release concept SCMs.
- New incentives for the protection of natural open spaces and natural stormwater features.
- New methods for the completion of the pre-development site characterization required by the regulations, including infiltration testing.
- Introduction of methods for adjusting precipitation depths for stormwater analysis based on the known effects of climate change.
- New guidance regarding: antidegradation requirements; the determination of discharge points and points of analysis; analyses of stream stability and erosion potential; off-site stormwater management; the evaluation of thermal impacts; and the assessment of projects located in areas of karst geology.

The McKean County Conservation District was organized at the request of the County residents. The County was declared a District by the board of County Commissioners on August 19, 1959, according to provisions of the Soil Conservation Law of 1945, Act 217 of the General Assembly, as amended.

The primary goal of the District is the development, improvement, and conservation of the County's Soil, water and related resources as well as educating the community in various conservation and environmental practices and methods.

The District is administered by a board of seven Directors-three farmer members, three public (non-farmer) members and one County Commissioner. District Directors are appointed by the County Commissioners from a list of names submitted by countywide nominating organizations. The Commissioners also designate one of their members to serve as a Director.
